**WHEREAS**, The State acquired the area known as the West Bank through the victory of the Six Day War of 1967, whereby the West Bank Palestinians became subjects of occupation; and

**WHEREAS**, The State enacted laws forbidding Palestinians to naturalize as Israeli citizens due to the strong voting power of the Palestinians; and

**WHEREAS**, The State has certain powers to override existing laws and the procedures to modify such if there is an immediate benefit to The State during a war, such as a shortening of the war, or the general safety of the citizens of The State, whereby The State desires to take action to accomplish such; and

WHEREAS, dissatisfaction and unfortunate suffering have resulted from the self governance of the West Bank Palestinians and also from the current Iron Swords War, rendering it impracticable for The Person to live comfortably, and as a result of which The undersigned Person is now seeking a better governance through The State in order to establish equality, justice, tranquility, safety, protection, and liberty for The Person and his posterity; and

**WHEREAS**, The Sides, through this Agreement, completely determine and forever settle the following:

- **A.** The rights and obligations of The Person;
- **B.** The obligations of The State;
- C. The obligations of HaLikud;
- **D.** All other benefits and rights conferred upon each other and all obligations imposed upon each by virtue of their presence within the boundaries of The State or otherwise; and

WHEREAS, each of The Sides acknowledges that they have reviewed in detail all of the terms of this Agreement, and have had this Agreement in their individual possession and control prior to the execution thereof, and have had the opportunity and ability to secure independent counsel and advice as to this Agreement and all the terms and conditions thereof;

**NOW THEREFORE**, The Person, The State and HaLikud hereby agree with each other as follows:

#### 1 INTRODUCTION

The introduction to this Agreement constitutes an inseparable part of it.

#### 2 RENUNCIATION OF FORMER POWERS

The Person hereby renounces all allegiance to the state of Palestine, including but not limited to the Palestinian Liberation Organization, Palestinian National Authority, Fatah, President Mahmoud Abbas, Prime Minister Mohammad Shtayyeh, Speaker of Parliament Aziz Dweik, any member of the National Council, Hamas, Ismail Haniyeh, Yahya Sinwar, Mohammed Deif, Palestinian Islamic Jihad, Popular Front for the Liberation of Palestine, Democratic Front for the Liberation of Palestine, Popular Resistance Committees, Popular Front for the Liberation of Palestine - General Command, Hezbollah, Ansar Allah, Amal Movement, the United Nations, and any other governing entity (collectively hereinafter: "Former Powers"), and all political connection between The Person and Former Powers is totally dissolved.

**3 ALLEGIANCE TO THE STATE** The Person pledges allegiance to The State and will not engage in any action against The State, including but not limited to participation in or support of: Jihad, terrorism, acts of violence, kidnapping or the formation of private military organizations.

### **4 CITIZENSHIP**

- (a) The State will grant full Israeli citizenship to The Person, including the issuance of Israeli ID and passport, after completion of an expedited naturalization process as to be determined by the Ministry of the Interior. The Ministry of the Interior will make every effort to complete the naturalization as quickly as possible.
- **(b)** The Person will cooperate with the Ministry of the Interior, providing whatever documentation is necessary within a reasonable amount of time in order to complete the process of naturalization.

- **6 RIGHTS** The State will enforce the rights of the naturalized Person the same as provided to Israeli citizens, including but not limited to the right to freedom of speech, freedom of the press, freedom of religion, use of public transportation, and more specific rights as follows:
  - (a) Freedom of movement to go anywhere within the borders of Israel, except that The Person will not go into Gaza or any future restricted areas designated by The State as being unsafe for Israeli citizens.
  - **(b)** Freedom to rent, buy, rent out, or sell real estate, to live or for business, from any Israeli citizen or to any Israeli citizen, anywhere within the borders of The State, except for the following areas:
    - 1) Any part of Jewish religious sites, including but not limited to the Jewish Quarter of the Old City of Jerusalem, the Jewish Quarter of Hebron, Safed, and Tiberius.
    - 2) Any part of the settlements.
    - **3)** Any part of religious Jewish communities, especially those that are closed on the Sabbath.
    - **4)** Any part of West Jerusalem.
    - **5)** Any strategic military location, at the discretion of The State.

And providing that The Person follows all local community rules without objection and treats neighbors respectfully and peacefully.

- **(c)** Freedom from harassment by The State directed specifically towards Palestinians, such as unwarranted inspections at checkpoints and other psychological harassments carried out by the IDF or police.
- (d) The right to have fair wages, fair work hours, workers' compensation, and all employment benefits the same as all other Israelis.

- **(e)** The right to be protected by The State military, especially during the current Iron Swords War or any future conflict with Former Powers.
- **(f)** The right to serve in The State military, except for during the current Iron Swords War or any future conflict with Former Powers.
- (g) Any rights granted in the future to the citizens of Israel will equally apply to The Person, except for specific limitations contained within this section, and concerning national security specified in Section 11, and voting and representation agreements specified in Sections 13 and 14.

7 HEALTH STANDARDS The State will enact regulations to ensure that the health standards of The Person after being naturalized are of the same quality as all parts of Israel, including but not limited to: Drinking water quality, sewage waste water processing, food sanitation standards, asbestos abatement, disposal of biohazards, workplace safety, agricultural hazard management, industrial waste management, water pollution prevention, air quality protection, and more specific health standards as follows:

- (a) The burning of garbage will be illegal, unless in an authorized incinerator facility.
- **(b)** Regulations for garbage collection and disposal will be enforced.
- (c) Recycling facilities will be provided as in all other parts of Israel.

**8 CONVENIENCES** The State will provide access to parks, recreational facilities, and tourist attractions for The Person after being naturalized, the same as for all Israelis.

<b>9 PROPERTY</b> The State will facilitate the transfer of any property that has a certificate of registration to the relevant departments of The State, including but not limited to: Real estate deeds, business entities, and vehicle registration and licensing. All property becomes subject to Israeli taxation and fees, equal to all other Israeli citizens.
10 MUNICIPALITIES The State will create a temporary government department to supersede any municipality that has been displaced by The Person's naturalization. Said department will function the same as an Israeli municipality, until such time that an Israeli municipality can be established practically.

- 11 <u>LAWS</u> All of The Sides will follow all laws of The State and any that may be enacted in the future, including but not limited to the following:
  - (a) The State will enforce equality laws to discourage discrimination against The Person to ensure equality with every other Israeli citizen, with the exception that The State will not allow any application of law that may jeopardize the national security of The State.
  - **(b)** The State will enforce existing agricultural land preservation laws limiting the development of farmland same as everywhere in The State.
  - **(c)** The State will enforce existing zoning laws and building restrictions, equal to every Israeli municipality.
  - (d) The Person will follow any temporary safety restrictions, including but not limited to the evacuation of war zones.
  - **(e)** The Person will follow all local laws wherever they reside.

#### 12 CHILDREN

- (a) The Person acknowledges that any existing minor child must have his own separate signed agreement if the minor wants to become a citizen. In such case, The Person must sign on behalf of his minor child, and if the minor is old enough to comprehend a legal contract, the minor will sign his own agreement with The Person. The Person acknowledges that he is responsible for the behavior of any child for whom he signed.
- (b) All of The Person's descendants, including:

(collectively hereinafter: "The Descendants")

will be included in this Agreement, and fully entitled to all the benefits and rights granted herein, as well as all obligations imposed as outlined in this Agreement, by virtue of their genealogy, excluding any future progeny of existing children who did not naturalize upon the effective date of this Agreement. This clause does not prevent any non-naturalized progeny from signing their own agreement in the future.

- 13 <u>VOTING AND REPRESENTATION</u> The Person acknowledges that HaLikud is the political entity that granted equality to The Person and The Descendants, therefore:
  - (a) HaLikud will represent the best interests of The Person and The Descendants in order to fulfill all the obligations of this Agreement within the bounds of its political jurisdiction.
  - **(b)** The Person waives his right to vote in Knesset elections.
  - (c) The State will automatically count a vote from The Person and votes from each of The Descendants, when they become of legal voting age, as if The Person and The Descendants had gone to the polling place and had voted for HaLikud, in all future Knesset elections, forever and ever, irrespective of any Israeli or non-Israeli spouse. If there is ever a dispute concerning the genealogy of The Descendants, The State will determine a proper course of action.
  - (d) The Person and The Descendants will retain their right to vote in local Israeli elections.

- **14 FAILURE TO REPRESENT** If HaLikud ever dissolves or fails to represent The Person or The Descendants:
  - (a) The State will enact laws to assure that all clauses in this Agreement will be upheld and continue uninterrupted in the spirit of this Agreement, as well as the votes being counted to a party of equivalent ideology of the 2022 HaLikud election campaign.
  - **(b)** No political party endorsing the subversion of The State as a Jewish homeland will ever supersede HaLikud.
- **15 FAILURE TO COMPLY** If The Person defaults on any of the obligations of this Agreement, he will be subject to the laws of The State, even in the event that he revoked his Israeli citizenship.

16 EFFECTIVE DATE The date in which this Agreement becomes effective will be the date on which the last of the three The Sides sign. The Person acknowledges that there is no guarantee that The State or HaLikud will sign this Agreement, and that if The State and HaLikud sign, it may take considerable time to implement all of the obligations of this Agreement.

**17 <u>FULL UNDERSTANDING</u>** The Person, The State, and HaLikud each acknowledge that they, respectively;

- (a) Are fully informed as to the facts relating to the subject matter of this Agreement and as to the rights and obligations of all The Sides.
- (b) Sign this Agreement voluntarily, without duress from the others.
- **(c)** Have dedicated careful and mature thought concerning the decision to sign this Agreement.
- **(d)** Have carefully read each provision of this Agreement.
- **(e)** Fully understand each provision of this Agreement, both with regard to the subject matter and legal effect.
