TERMS OF USE FOR ALTISAW

Effective date: March 30, 2024

These Terms of Use ("Terms") govern any interaction with our company ALTISAW LLC ("we" or "us" or "our" or "Altisaw") and the use of our website,

https://www.altisaw.com ("Site").

We welcome you ("you" or "Participant") as a reader, or potential signer of an agreement, and we encourage you to join our peaceful movement. Before you participate, however, we ask that you please read and agree to the following Terms, because any interaction with us, access to our Site or use of our Site's features ("Services") signifies your agreement with these Terms.

Overview

These Terms tell you about our public Services at Altisaw, our relationship to you as a Participant, and the obligations, rights and responsibilities that guide us

both.

These Terms were written in American English. We hope that translations of these Terms are accurate; however, in the event of any differences in meaning between the original English version and a translation, the original English version takes precedence.

1. Copyrights and Trademarks

(a) **All Rights Reserved**: All materials published on the Site or the Services, including but not limited to text, photographs, images, illustrations, flag designs, agreements, audio clips and video clips (collectively, "Content"), are protected by copyright and trademark laws and owned or controlled exclusively by Altisaw. Any use of our trade name, domain name, trademarks, service marks, logos, flag designs, flags or other products containing such

insignia ("Insignia") must be in compliance with these Terms.

(b) **Personal Restrictions**: Content may only be viewed for your personal, non-commercial benefit. You may not store, copy, print, reprint, repost, redistribute, electronically catalogue, modify, create derivative works of or otherwise use our Content, or any portion thereof, for any purpose in any form without our express permission in writing, even for personal use, except where expressly stated in Section 3 (e) of these Terms. Any other use is strictly prohibited.

- (c) **Concerning Journalists**: Content will not be published, broadcast, rewritten for broadcast or publication or redistributed directly or indirectly in any medium or otherwise used for any purpose in any form without our express permission in writing.
- (d) **Concerning Website Links**: Content will not be hot-linked or shared within another website. Any link to our Site must be authorized with our express permission in writing, and use pre-approved language associated with the link.
- (e) **Flag Designs**: You agree to refrain from any misrepresentation regarding the symbolism behind our Insignia. Our flag designs are each displayed on our Site and officially described as follows:

(1) **Altisaw Flag** [The Equality Flag] © 2023 TM

- (i) *Description*: A red heart outline between a black horizontal stripe above and a green horizontal stripe below on a white field.
- (ii) *Symbolism*: Our Altisaw [The Equality] Flag consists of a white background, signifying the purity of non-violent deeds, with a red heart outline in the center, signifying love of the State of Israel, a black horizontal stripe at the top, signifying the defeat of jihad terrorism against Zionism, and a green horizontal stripe at the bottom, signifying the Holy Land being divinely given to the Jews according to the Qur'an and Torah, and the overall layout recalling the design of the Israeli national flag fused with the colors of the Palestinian national flag to emphasize the equality of Palestinian Arabs and Israeli Jews in the State of Israel. The theme is political equality.

(2) Peace Flag of the Promised Land © 2023 TM

- (i) **Description**: A flying white dove inside a red heart, between a black horizontal stripe above and a green horizontal stripe below on a white field.
- (ii) *Symbolism*: Our Promised Land Peace Flag consists of a white background, signifying the purity of world peace, with a solid red heart in the center, signifying love of humanity, a white dove flying within the heart, universally signifying peace, a black horizontal stripe at the top, signifying the defeat of ethnic hatred in the world, and a green horizontal stripe at the bottom, signifying the Promised Land being divinely given to the Jews according to the Qur'an and Torah, and the overall layout recalling the design of the Israeli national flag fused with the colors of the Palestinian national flag to emphasize the peace between Gentiles and Jews in the world. The theme is world peace starting in the Middle East.

(3) Peaceguy Flag © 2016 TM

- (i) **Description**: A solid red heart between a black horizontal stripe above and a green horizontal stripe below on a white field.
- (ii) *Symbolism*: The original Peaceguy Flag consists of a white background, signifying the purity of brotherhood, with a solid red heart in the center, signifying love between Muslims and Jews, a black horizontal stripe at the top, signifying the defeat of religious hatred between Islam and Judaism, and a green horizontal stripe at the bottom, signifying the Holy Land being divinely given to the Jews according to the Qur'an and Torah, and the overall layout recalling the design of the Israeli national flag fused with the colors of the Palestinian national flag to emphasize the equality of Muslims and Jews. The theme is religious tolerance.

2. Content We Publish

- (a) You may find some Content objectionable: Because we publish controversial Content that is produced by our staff, you may encounter Content that you find offensive, suggestive, or otherwise objectionable. We therefore ask that you use common sense and proper judgment when using our Services.
- (b) The Content is for general informational purposes only: Although our Site publishes a great deal of controversial information that pertains to governmental topics, including leadership, legal, or political issues, this Content is presented for general informational purposes only. It should not be taken as professional advice. Please seek independent professional counseling from someone who is licensed or qualified in the applicable area in lieu of acting on any information, opinion, or advice contained in any Content published on our Site.
- (c) **The Content is unsolicited**: Altisaw has in no way been paid by, sponsored, or solicited by any government entity or political party to distribute any Content, idea or opinion.

3. Published Content Involving Third Parties

Highlighted for emphasis.

If you are a West Bank Palestinian, please read this section very carefully.

- **(a) Agreement**: Altisaw offers an agreement ("The Agreement") involving the State of Israel and the political party Likud ("Third Parties") and West Bank Palestinians. Only West Bank Palestinians can sign The Agreement because it does not cover anyone outside the jurisdiction of the current boundaries of the State of Israel. Altisaw is in no way a party to The Agreement.
- **(b) No Enticement**: Neither Altisaw nor any of our staff, representatives, volunteers, directors, officers, managers, contractors, employees, or agents was ever solicited, paid, or prompted by the Third Parties or anyone to offer The Agreement on our Site.
- (c) **Certification**: By electronically signing The Agreement, you certify that you are the actual person matching the details entered, or that you are an authorized agent of such, or that you are the parent or guardian signing on behalf of your minor child.
- (d) The Agreement is legally binding: If and when The Agreement is signed by all parties, it becomes legally binding upon the parties.
- **(e)** For legal advice: Please seek independent professional legal advice from someone who is licensed or qualified in the applicable areas of law before signing The Agreement.
- **(f) Copyright exception**: If, but only if, you decide to sign The Agreement, you may save and store one signed copy of The Agreement after you sign it for your own records without violating our copyright policy in Section 1 (b), and need to do so in order to be able to email it to us. Your own signed copy may be printed for your own convenience.
- **(g) Disclosure**: You acknowledge and understand that if you decide to sign The Agreement and email it to us, you are hereby also agreeing to the sharing of your decision with the Third Parties as a necessity.
- (h) Actions: Altisaw is not responsible for any actions of the Third Parties. You release Altisaw, its subsidiaries and affiliates, and each of their directors, officers, managers, agents, contractors, employees, partners, staff, representatives, and volunteers from any claims and damages, known and unknown, arising out of or in any way connected with any claim you have against the Third Parties. You acknowledge that there is no guarantee that the Third Parties will sign The Agreement, and that even if all parties sign, it may take considerable time to implement all of the obligations of The Agreement.
- **(i) Storage**: You agree that we have no responsibility or liability for the deletion of, or the failure to store or to transmit, any Content or communication maintained by the Services, or any information you send to us, including but not limited to The Agreement you signed and emailed to us.

4. Privacy Policy

(a) Concerning the Site

- (1) **Non-identifiable data**: We reserve the right to gather broad demographic information for aggregate use in order to learn how our customers and the public are using our Site. We may use this information to enhance our Site or Services or for other lawful purposes such as copyright protection. We do not sell aggregate data.
- (2) **Personal data**: In an effort to protect your identity, we do not knowingly collect, track, or use any personally identifiable data about you, other than any information that you provide us willfully. We do not use cookies, web beacons, or Google Analytics on our Site.

(b) Concerning The Agreement

Highlighted for emphasis.

- (1) Anyone Outside of the West Bank: If you are a Palestinian living outside of the West Bank, please do not sign The Agreement. Only West Bank Palestinians can sign The Agreement because it does not cover anyone outside the jurisdiction of the current boundaries of the State of Israel.
- (2) The Agreement: The information provided on The Agreement is intended for the Third Parties, who already have access to West Bank Palestinians' information. We do not share information that West Bank Palestinians provide in The Agreement or information about West Bank Palestinians signing The Agreement with anyone other than the Third Parties. We reserve the right to check The Agreement to verify that all required fields have been filled out.
- (3) Storage of The Agreement: The security of your data is important to us, but remember that no method of transmission over the Internet, or method of electronic storage, is 100% secure. While we strive to use commercially acceptable means to protect your personal data, we cannot guarantee its absolute security. We contract an encrypted email service in an effort to protect the transfer and storage of The Agreement on our end. We cannot stop eavesdroppers, hackers, or the like on your end, and therefore recommend that you send us your signed version of The Agreement via a similar encrypted email service to protect your end.

(c) Concerning Children's Privacy Worldwide

Highlighted for emphasis.

- (1) **Children**: If you are under the age of thirteen (13 years old), you are expressly prohibited from accessing/viewing the Site. All children under the age of thirteen (13) who want to sign The Agreement must have a parent or guardian sign with them on The Agreement. We are not allowed to gather personal information from minors in accordance with The Children's Online Privacy Protection Act of 1998 (COPPA).
- (2) **Parents**: You agree that by submitting information about a child under the age of thirteen (13 years old), the information is from you. We do not knowingly collect, use, or disclose personally identifiable information from visitors younger than 13 years of age. If you are the parent or guardian of a child under 13 years of age and believe that they have disclosed personally identifiable information to us, please contact us so that we may delete your child's information.

(d) Concerning Children's Privacy for Residents of the UK, EEA, and Switzerland

- (1) **Children**: We do not intentionally or knowingly collect, use, or disclose personally identifiable information about EU Participants that are less than 16 years of age. If a minor under the age of 16 submits information to us through any part of the Site or Services and we become aware that the Participant submitting the information is under the age of 16, the information provided will be deleted as soon as it is discovered and not used for any purpose.
- (2) **Parents**: If you are the parent or guardian of a child under 16 years of age and believe that they have disclosed personally identifiable information to us, please <u>contact us</u>, and please include in your message the same name and email address that you believe your child submitted, if applicable.

(e) Concerning Information Disclosure

We reserve the right to access, use, preserve, and/or disclose your personal information to the appropriate authorities, advisors or attorneys in the following circumstances:

(1) **Law**: To comply with a legal obligation. By law, we can access, use, preserve, and/or disclose your personal information if we reasonably believe it necessary to satisfy a valid and legally enforceable warrant, subpoena, court order, law or regulation, or other judicial or administrative order.

- (2) **Our Protection**: To protect and defend the rights, property or personal safety of Altisaw, its subsidiaries and affiliates, and each of their directors, officers, managers, agents, contractors, employees, partners, staff, representatives, and volunteers.
- (3) **Your Protection**: To protect your personal safety, that of other Participants, or the public if we believe that it's reasonably necessary to prevent imminent and serious bodily harm or death to a person.
- (4) **Investigation**: To prevent or investigate possible wrongdoing in connection with the Site or Services, including but not limited to potential spam, malware, fraud, abuse, unlawful activity, and security or technical concerns.
- (5) **Liability**: To protect against legal liability.

(f) Concerning Participants Residing in California

The California Consumer Privacy Act of 2018 ("CCPA") provides certain protections and rights for California consumers. If you are a consumer residing in California, the following additional terms apply to you.

- (1) **Collection**: We do not collect any personal information other than what you willfully provide us in order to purchase and ship you any products you might buy through our Services.
- (2) **Disclosure**: We do not disclose or sell any aggregate or personal data from your purchase, other than for necessary purposes listed above in the previous Subsection (e) of this Section.

5. Communication

- (a) **Notices**: You agree that we may, but are not obligated to, provide you with notices, including those regarding any future updates to these Terms or the future acceptance of The Agreement, by email, or postings on our Site.
- (b) **Opt out**: You may opt out of email notices by sending an email to our admin with the subject note: "Request to opt out of emails."
- (c) **Regular Email Inquiries**: You agree to send any email other than The Agreement to our regular, unencrypted email account, listed on our <u>contact us</u> page.
- (d) **The Agreement**: If you decide to sign The Agreement, you agree to send it to our special encrypted email account, listed on our homepage in the <u>instructions</u> section.

(e) **Postal Mailings to our Registered Agent**: You agree that you will not send any mail to our Registered Agent, other than legal claims or service of process. You agree to pay any and all costs incurred by or associated with the handling, opening, scanning, uploading, transmitting, delivery, or forwarding of any mail you send, and any reply we may be required to send in return through our Registered Agent. You agree to authorize us to take legal action in order to retrieve reimbursement of costs you incurred us.

6. Representing Our Community

Highlighted for emphasis.

- (a) **Altisaw Community**: We happily welcome your participation. We consider all Participants and staff of Altisaw as part of our movement ("Community"). Anytime you use or display any of our Insignia, sign The Agreement, talk about, show support for, endorse, or act on behalf of Altisaw, you are representing our Community.
- (b) **Non-violent behavior**: You agree to be civil and polite in your interactions with others inside and outside our Community, act in good faith, and with non-violence at all times.
- (c) **Risk**: You agree that representing our Community, including but not limited to your use or display of any Insignia, is at your own risk.
- (d) **Enemies of Israel**: Due to similarities of our Insignia to the Israeli flag, depending on context, the use of our Insignias may be considered illegal in Iran, Iraq, the Gaza Strip, Syria and other countries.

7. Refraining from Certain Activities

Certain activities, whether legal or illegal under the applicable law, may be harmful to others and violate our Terms, and some activities may also subject you to liability. Therefore, for your own protection and for that of others, you may not engage in such activities while representing the Community. These activities include:

(a) Harassing and Abusing Others

- (1) **Harassment**: Engaging in threats, stalking, spamming, vandalism, or harassment;
- (2) **Spam**: Transmitting chain mail, junk mail, or spam to other Participants; and,

(3) **Harm**: Stating publicly any information with the intention to seriously harm others, such as deliberate inducements to self-harm, deliberate triggering of epilepsy, heart attacks, or suicide.

(b) Violating the Privacy of Others

- (1) **Rights**: Infringing the privacy rights of others under the laws of the United States of America or other applicable laws (which may include the laws where you live or where you view our Content);
- (2) **Soliciting**: Soliciting personally identifiable information for the purposes of harassment, exploitation, or violation of privacy, or for any promotional or commercial purpose not explicitly approved by Altisaw; and,
- (3) **Children**: Soliciting personally identifiable information from anyone under the age of 18 years, or under the age of majority where you are if higher than 18 years, for an illegal purpose or violating any applicable law regarding the health or well-being of minors.

(c) Engaging in False Statements, Impersonation, or Fraud

- (1) **Libel**: Intentionally or knowingly stating publicly any information that constitutes libel or defamation under the laws of the United States of America;
- (2) **Deception**: Stating publicly any information with the intent to deceive or mislead others;
- (3) **Impersonation**: Attempting to impersonate anyone in the Community, misrepresenting your affiliation with any individual or entity, hiding your affiliation with any individual or entity when disclosure is required, or using the name of Altisaw or anyone in the Community with the intent to deceive; and,
- (4) **Fraud**: Engaging in fraud, including but not limited to signing The Agreement for someone else without their permission, or entering false information therein.

(d) Committing Infringement of Intellectual Property Rights

Infringing copyrights, trademarks, patents, or other proprietary rights under the applicable law.

(e) Using Our Insignia Illegally

Displaying our Insignia in any way or in any country that may ban or make illegal the use of any Insignia signifying our cause.

(f) Engaging in Disruptive or Illegal Misuse of Facilities

- (1) **Hacking**: Knowingly accessing, tampering with, or using any non-public area of our staff's computer system or technical infrastructure, or our hosting server's computer system or technical infrastructure;
- (2) **Viruses**: Hacking or intercepting data on our Site in order to distribute any virus, malware, worm, Trojan horse, malicious code, time bomb, cancelbot, harmful code, disruptive code, or any other component or device that could harm any computer system or technical infrastructure of our staff, our hosting server, or other Participants;
- (3) **Disruption**: Engaging in any use of our Site that disrupts our Services, whether automated or manually, or that interrupts our Services by placing an undue burden on our hosting servers;
- (4) **Email**: Disrupting our Services by inundating any of our email accounts with solicitations or other unnecessary communications;
- (5) **Encrypted Email**: Sending any email other than The Agreement to our encrypted email account; and,
- (6) **Testing**: Probing, scanning, or testing the vulnerability of any computer system or technical infrastructure of our staff, our hosting server, or other Participants (excluding such done by our hosting server's staff or bots).

8. <u>Disputes and Jurisdiction</u>

Highlighted for emphasis.

- (a) **Disagreements**: We hope that no serious disagreements arise involving you, but, in the event there is a dispute, we encourage you to seek resolution through contacting us directly before you file a formal claim.
- (b) **Forum**: If you seek to file a legal claim against us, you agree to file and resolve it exclusively in a state or federal court located in Bernalillo County, New Mexico. You also agree that the laws of the State of New Mexico and, to the extent applicable, the laws of the United States of America will govern these Terms, as well as any legal claim that might arise between you and us (without reference to conflict of laws principles). You agree to irrevocably submit to the personal jurisdiction of, and agree that venue is proper in, the courts located in Bernalillo County, New Mexico, in any legal action or proceeding relating to us or these Terms, and waive any defense of inconvenient forum.

- (c) **Language**: The Content of our Site in Arabic and Hebrew are translations from the English version for your convenience only. In the event of any difference in meaning or interpretation between the English language version of Content and either translation, the English language version will prevail. You agree that the original English text of all Content, including these Terms, will be the sole legally binding version. You also agree that any claims filed must be submitted and adjudicated in 5a Yf]Wb English.
- (d) **Time Limit**: To ensure that disputes are dealt with soon after they arise, you agree that regardless of any statute or law to the contrary, any claim or cause of action you might have arising out of or related to use of our Services or these Terms must be filed within the applicable statute of limitations or, if earlier, one (1) year after the pertinent facts underlying such claim or cause of action could have been discovered with reasonable diligence (or be forever barred).
- (e) **No class action**: To the fullest extent permitted under law, you agree that any claim will be in individual capacity and not as a plaintiff or class member in any purported class or representative proceeding.
- (f) **Procedure**: All claims you bring against us must be resolved in accordance with this Section. All claims filed or brought contrary to this Section will be considered improperly filed. Should you file a claim contrary to this Section, we may recover attorneys' fees and reimbursement of its costs, provided that we have notified you in writing of the improperly filed claim, and you have failed to promptly withdraw the claim.

9. Indemnity

- (a) **Altisaw**: You agree to defend, indemnify and hold Altisaw, its subsidiaries and affiliates, and each of their directors, officers, managers, agents, contractors, employees, partners, staff, representatives, and volunteers harmless from any loss, liability, claim, damages, costs, debts, expenses or demand, including reasonable attorney's fees, due to or arising from:
 - (1) **Use**: Your use of or access to our Site or Services, including any data or Content transmitted or received by you, or your inability to use our Services:
 - (2) **Content**: Any claim or damages that arise as a result of anything connected with Content, Services, the Community, or your displaying or use of any Insignia, including without limitation any right of privacy, any bodily injury, emotional distress, or loss of life;

- (3) **Information you submit**: Any claim or damages that arise as a result of any of your information that you submit, including without limitation any right of privacy, your loss of benefits, rights, conveniences, or any bodily injury, emotional distress, or loss of life;
- (4) **Hacking**: Any claim or damages that arise as a result of any theft, destruction or unauthorized access to Altisaw's records, including without limitation any right of privacy, your loss of benefits, rights, conveniences, or any bodily injury, emotional distress, or loss of life;
- (5) **Delay**: Any claim or damages that arise as a result of a delay in presenting The Agreement to the Third Parties, including without limitation our inability to contact Third Parties;
- (6) **You**: Your conduct in connection with or resulting from any of our Content or Services, or representing our Community, including without limitation any personal injury or loss of life;
- (7) **Breach**: Your violation of any of the terms of these Terms, including without limitation your breach of any of the representations and warranties herein:
- (8) **Third Party Right**: Your violation of any rights of a third party, including without limitation any right of privacy or safety;
- (9) **Theft**: Any other party's use of your information that you submit, including without limitation any right of privacy or your signing of any agreement; or,
- (10) **Breaking the law**: Your violation of any applicable laws, rules or regulations, including without limitation your displaying or use of any Insignia.
- (b) **Third Parties**: You agree to defend, indemnify and hold Third Parties, their subsidiaries and affiliates, and each of their directors, officers, managers, agents, contractors, partners and employees harmless from any loss, liability, claim, damages, costs, debts, expenses or demand, including reasonable attorney's fees, due to or arising from:
 - (1) **Your Signature**: Any claim or damages that arise as a result of anything connected with your signing of The Agreement, including without limitation any right of privacy, any bodily injury, emotional distress, or loss of life;
 - (2) **Delay**: Any claim or damages that arise as a result of a delay in the processing of The Agreement, including without limitation your inability to contact Third Parties;

- (3) **Theft**: Any other party's use of your information that you submit, including without limitation any right of privacy; or,
- (4) **Breaking the law**: Your violation of any applicable laws, rules or regulations.

10. Disclaimers

Highlighted for emphasis.

- (a) **As Is**: Altisaw provides the Site, Content and Services on an "as is" and "as available" basis. To the maximum extent permitted under applicable law, we expressly disclaim any warranties or representations of any kind, whether express, implied, statutory or otherwise with respect to the Site, Content and Services, including but not limited to the implied warranties of merchantability, fitness for a particular purpose, and non-infringement.
- (b) **Losses**: Altisaw does not take responsibility for any loss caused to Participants as a consequence of accessing Content on our Site or Services. We will not be held liable for any delays, interruptions, inaccuracies, errors or omissions therefrom or in the transmission or delivery of all or any part of Content or for any damages arising from any Content, and your reliance on Content is at your sole risk. We do not guarantee that our Site will remain secure, that your information will be secure, that the Content or Services are free of viruses or other computer infection, or that our Services will meet your requirements. Any Content downloaded or otherwise obtained through your use of our Services is done at your own discretion and risk, and you will be solely responsible for any damage to your computer system or loss of data that results from the download of any such Content. Altisaw will not be responsible for the loss of life of anyone representing the Community. Altisaw will not be held liable for your display or use of any Insignia.

- (e) **Non-applicability**: Some states or jurisdictions do not allow the types of disclaimers in this section, so they may not apply to you either in part or in full depending on the law.

11. Limited Liability

Highlighted for emphasis

- (a) **Damages**: Altisaw will not be liable to you or to any other party for any direct, indirect, incidental, special, consequential or exemplary damages, including but not limited to, damages for loss of profits, goodwill, use, data, or other intangible losses, regardless of whether we were advised of the possibility of such damage. In no event shall our liability exceed one hundred U.S. dollars (\$100.00) in aggregate.
- (b) **Non-applicability**: Some states or jurisdictions do not allow the limitation or exclusion of liability in this section, so it may not apply to you either in part or in full depending on the law. In the case that applicable law may not allow the limitation or exclusion of liability or incidental or consequential damages, our liability will be limited to the fullest extent permitted by applicable law.

12. Modifications to these Terms

Because it may be necessary to modify these Terms from time to time, therefore, we ask that you please periodically review the most up-to-date version of these Terms. Your continued use of our Site or Services after any new Terms becomes official constitutes an acceptance of these new Terms on your part.

13. Full Understanding

- (a) **Sole contract**: You agree that these Terms contain the entire agreement between you and Altisaw regarding the use of our Site and Services and supersede all prior agreements and understandings (including without limitation any prior versions of these Terms).
- (b) **Use of Site**: If you do not agree with our Terms, you cannot use our Site or Services.
- (c) **Clarification**: You agree that you:
 - (1) Use our Site and Services voluntarily, without duress.
 - (2) Have carefully read each provision of these Terms.
 - (3) Fully understand each provision of these Terms, both with regard to the subject matter and legal effect.
 - (4) Are age thirteen (13) or older.

14. Miscellaneous

- (a) **Reporting Criminals**: If Altisaw believes, in its sole discretion, that a violation of these Terms or any illegal or inappropriate behavior has occurred, we may take any other corrective action we deem appropriate. We reserve the right to investigate suspected violations of these Terms or illegal and inappropriate behavior on our Site or concerning our Services. We will fully cooperate with any law enforcement authorities or court order requesting or directing us to disclose the identity, correspondence and behavior of anyone believed to have violated these Terms or to have engaged in illegal behavior on our Site or concerning our Services.
- (b) **No alliance**: You agree that no joint venture, partnership, employment, or agency relationship exists between you and Altisaw as a result of these Terms, use of our Site or Services, or representing our Community.

15. No Waiver
